



## MEMORANDUM OF UNDERSTANDING

**Xelpmoc Design and Tech Ltd., a technology and innovation company located at: 8th Floor, Raheja Mindspace, Building No. 4, HITEC City, Hyderabad, Telangana 500081 hereinafter referred to as "Xelpmoc".**

Collectively referred to as the "Parties", and individually as a "Party".

### 1. PURPOSE

The purpose of this MoU is to establish a framework of cooperation and collaboration between DBS College and Xelpmoc in the field of Artificial Intelligence (AI) and Machine Learning (ML), specifically focused on applications in the education sector. This collaboration is purely for educational and knowledge-sharing objectives and aims to build academic-industry linkages that promote joint research, innovation, and skills development.

### 2. OBJECTIVES

The primary objectives of this MoU include:

- Joint research initiatives in AI/ML applications for education and learning technologies.
- Organization of workshops, webinars, guest lectures, and training programs for students and faculty.

- Facilitation of mutual visits, resource sharing, and technical mentorship.



### 3. SCOPE OF COLLABORATION

The collaboration may include, but is not limited to:

- Conducting joint academic research projects and publishing papers.
- Co-developing curricula, modules, and learning materials related to AI and ML.
- Facilitating access to Xelpmoc's technology platforms, sandbox environments, or APIs where possible for learning purposes.
- Engaging faculty and industry mentors in technical training sessions.
- Encouraging participation in innovation challenges, hackathons, and ideation forums.

### 4. ROLES AND RESPONSIBILITIES

DBS College shall:

- Nominate coordinators for overseeing the implementation of collaborative activities.
- Provide access to infrastructure (labs, seminar halls, etc.) for jointly hosted events.
- Encourage student and faculty participation in agreed-upon activities.

Xelpmoc shall:

- Provide technical experts and resource persons for lectures, workshops, and mentoring sessions.
- Share relevant research and development resources as permissible.
- Offer internship/project-based learning opportunities in select areas.

### 5. DURATION AND TERMINATION

This MoU shall remain in effect for a period of three (3) years from the date of signing, unless terminated earlier by either Party with 30 days' prior written notice. The MoU may be renewed or amended through mutual written consent of both parties.

### 6. NON-BINDING NATURE

This MoU is intended as a statement of mutual intent and does not create any legally binding obligations for either Party. No Party shall be liable to the other for any direct, indirect, or consequential losses arising from the collaboration.

### 7. CONFIDENTIALITY

Both Parties agree to maintain confidentiality of any non-public information exchanged under this MoU unless disclosure is required by law.

### 8. GENERAL TERMS

The Parties agree to maintain open and regular communication to ensure the effective implementation of this MoU. Both parties are expected to uphold principles of good faith, transparency, and mutual respect throughout the collaboration




