MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding (hereinafter referred to as the "MOU") is made and executed on this 20th day of February 2026,

BY AND BETWEEN

DBS College,

Govind Nagar, Kanpur, Uttar Pradesh – 208006,

Affiliated to Chhatrapati Shahu Ji Maharaj University, Kanpur,

Represented by Prof. Anil Kumar Mishra, Principal (hereinafter referred to as the "College"),

AND

Drishti IAS,

B2, Pusa Road, North Extension Area, Karol Bagh, New Delhi – 110005,

Through its Cluster Head, Lucknow,

Represented by Mohit Mishra,

(hereinafter referred to as "Drishti IAS").

The College and Drishti IAS shall collectively be referred to as the "Parties".

1. PURPOSE OF THE MOU

The purpose of this MOU is to establish a collaborative academic partnership between DBS College, Kanpur and Drishti IAS for the benefit of students preparing for competitive examinations such as UPSC, State PCS, and Judiciary Services.

Under this collaboration, Drishti IAS shall provide academic support and concessional benefits to eligible students of DBS College.

2. SCOPE OF COLLABORATION

Drishti IAS agrees to:

1. Provide a 15% discount on Offline Programme Fees (UPSC / State PCS / Judiciary) to students of DBS College.
 - o Students must present their valid College Identity Card to avail the discount.

2. Provide relevant books and preparatory material for Civil Services, Judiciary and PCS examinations to be placed in the College Library, in consultation with the College Librarian.
3. Arrange periodic visits of a designated mentor/faculty member to DBS College for:
 - o Interactive sessions
 - o Career guidance lectures
 - o Q&A sessions regarding Civil Services preparation
4. Provide monthly editions of Drishti UPSC / Judiciary / PCS magazines (Hindi & English) to the College Library.

3. RESPONSIBILITIES OF THE COLLEGE

DBS College agrees to:

1. Facilitate communication between Drishti IAS and interested students through:
 - o Notice boards
 - o Student groups (as per College policy)
2. Coordinate academic events/workshops related to Civil Services preparation subject to prior approval from the College administration.

4. RESPONSIBILITIES OF DRISHTI IAS

Drishti IAS agrees to:

1. Publicize the discount and academic benefits offered under this MOU.
2. Ensure timely delivery of books, magazines, and academic resources.
3. Conduct mentor visits and sessions as mutually scheduled.
4. Maintain academic and professional standards in all interactions with students.

5. DURATION

This MOU shall remain valid for a period of **One (1) Year**, effective from **20/02/2026** to **19/02/2027**.

The MOU may be renewed upon mutual written consent of both Parties.

6. TERMINATION

Either Party may terminate this MOU by giving **30 days' written notice** to the other Party.

7. AMENDMENTS

Any modification or amendment to this MOU shall be made in writing and signed by authorized representatives of both Parties.

8. GOVERNING LAW

This MOU shall be governed and interpreted under the laws of the State of Uttar Pradesh, India.

9. CONFIDENTIALITY

Both Parties agree to maintain confidentiality regarding any official information exchanged under this agreement and shall not disclose such information without prior written consent.

10. NON-FINANCIAL NATURE

This MOU does not create any financial liability on either Party except the discount commitment offered by Drishti IAS to eligible students.


